## DECISION

## ON FORM AND CONTENT OF THE REPORTS THAT THE LEASING OCMPANIES SUBMIT TO THE BANKING AGENCY OF FEDERATION OF BOSNIA AND HERZEGOVINA AND THE DEADLINES FOR REPORTING

#### Article 1.

This Decision prescribes the form and content of the reports on performance that the leasing company is obliged to submit to the Banking Agency of Federation of Bosnia and Herzegovina (in further reading: FBA) and the deadlines for reporting.

## Article 2.

The reports from the Article 1., of this Decision are monthly and quarterly.

#### Article 3.

(1) The monthly report of the leasing company is the Report on the risk weight nominal effective interest rates (form: EKS).

(2) The deadline for the monthly reports is 15 days after the end of the reporting month.

#### Article 4.

- (1) Leasing company quarterly (in further reading: LD) reports are:
- 1. Balance Sheet LD (form: BS-LD);
- 2. Income Statement LD (form: BU-LD);
- 3. The list of owners of over 5% of participation in LD (form: K-LD);
- 4. Structure of receivables on the basis of the financial leasing (form: SPF-LD);
- 5. Structure of receivables on the basis of the operating leasing (form: SPO-LD);
- 6. Report on the amount and manner for allocating the reserves for losses (Reserve-FBA);
- 7. Review of 10 largest lessees (form: ND-LD);
- 8. Review of 10 largest sources of funds of LD (form: NI-LD);
- 9. Report on number and qualification structure of the employees of the LD (form: LD- Employees).

(2) The deadline for submitting the reports from the paragraph (1) of this Article is 30 days after the end of the reporting quarter, and the deadline for the last quarter of the previous year, prepared based on the preliminary data, is  $31^{st}$  of January of the current year.

(3) The deadline for submitting the report for the last quarter of the previous year, prepared based on the final date, is  $05^{th}$  of March of the current year.

Article 5.

The affiliates of the leasing company that operate in the Federation of BiH, which head office is in Republic Srpska, are obliged to, at FBA's request, submit reports from the Article 3., paragraph (1) and Article 4., paragraph (1) of this Decision within deadlines determined by FBA.

## Article 6.

The leasing companies are obliged to list all the amounts shown in the reporting forms from this Decision in 000 KM, unless it is stipulated otherwise.

Article 7.

(1) The reports from this Decision are submitted through adequate electronic media and their form must be adjusted to the requests of the FBA and the technical requests of such media.

(2) The leasing companies are obliged to (simultaneously), along with the quarterly reports, submit the form: LD-FBA signed by the director of the leasing company. The signature confirms that the attached reports are adopted by the Management, and that the reports are complete and correct.

## Article 8.

Forms from the Article 3., and 4., of this Decision are part of it and are to be found in its attachment.

## Article 9.

This Decision comes into effect on the eighth day from the day it is published in the "Official Gazette of the Federation of BiH ".
